AUTHORIZATION, ACKNOWLEDGEMENT AND RELEASE AGREEMENT

In consideration of Haliburton Hockey Haven Inc. (“HHH”) providing a camp program (the “Camp”) in which the undersigned’s child or children (each a “Camper”) is or are enrolled and other good and valuable consideration, the undersigned, on behalf of itself, the Camper and any other parent or legal guardian of the Camper, agrees in favour of HHH as follows:

(a) Medical Treatment: authorizes HHH or an individual employed or associated with HHH in the event of an emergency, to use reasonable discretion, on behalf of the undersigned, the Campers or associated spectators participating in or attendance at HHH's Camp, in rendering first aid and/or arranging for emergency medical care (including calling an ambulance or hospitalization), at the expense of the undersigned;

(b) Risks: acknowledges that (i) the undersigned is enrolling in the Camp willingly, (ii) the Camper is participating voluntarily in the Camp, (iii) there are risks associated with participation in activities associated with the Camp, (iv) accepts all such risks and agrees to be responsible for any injury or other loss which the undersigned or the Camper might receive or suffer while participating in Camp activities and programs;

(c) Release: releases HHH and its directors, officers, employees, contractors, affiliates, shareholders and agents (the “Releasees”) from any and all liability for any claims, demands, actions, costs, expenses and liabilities whatsoever (“Claims”) arising from or related to participating in or attendance at the Camp and any of its premises by the Camper, the undersigned or any associated spectator(s), whether in respect of bodily injury, loss or damage to person or property or otherwise, howsoever caused, and agrees to indemnify and hold HHH harmless from any and all Claims against any of the Releasees for any Claims.

(d) Refunds/Credits/Termination: acknowledges that there will be no make-up Camp dates for any missed days or period due to illness or other personal reasons of Camper and acknowledges that a refund or credit will only be available should a Camper withdraw (by written notice) at least 60 days before the Camp week in which the Camper is enrolled, subject to an administrative fee of \$10.00 for each registered Camp day. No refunds/credits will be available if less than 60 days’ prior written notice is provided for a cancelled week due to illness or other personal reasons. The Directors of the Camp reserve the right to terminate the registration of any Camper if, in their sole discretion, the Directors determine such termination to be in the best interest of the Camper or the Camp;

(e) Program Cancellation: acknowledges that while HHH tries to balance providing sufficient advanced noticed of cancellation and not cancelling any Camp week prematurely, in the unlikely event that an insufficient number of students have registered for a particular camp week, HHH reserves the right to

cancel such program. If camp weeks have to be cancelled for such reasons and no convenient alternative can be arranged, payment (if any) already made will be fully refunded;

(f) Policies and Information: acknowledges that the undersigned has read and understood all policies and information contained in this form and related materials distributed with this form and accepts the terms and conditions set out herein and therein;

(g) Publicity: acknowledges that photographers and videographers take pictures and videos on behalf of HHH of campers for use in various forms of advertising, websites, publications and social media and gives consent to HHH taking any of such photographs and video images of the Camper and the use by HHH of the Camper's likeness for publicity purposes in any form of media including social media without being captioned with the Camper's name;

(h) Electronics Free Policy: acknowledges that HHH has and will enforce a STRICT NO CELL PHONE/DEVICE/ELECTRONICS policy (including laptops, tablets, other computers, electronic games and other devices) for the enjoyment of Camp by all campers and that if Camper is found with or using them, they will be required to be checked with HHH Camp Staff for the duration of their stay; and

(h) Binding nature: agree that this agreement enures to the benefit of HHH and its successors and assigns and is binding upon the undersigned, any other parent or legal guardian of the Camper, the Camper and any of the undersigned and their respective heirs, legal representatives, successors and assigns.

Sun Exposure and Safety Policy and Procedures

Policy Statement

Due to the nature of the activities and programs designed by Haliburton Hockey Haven Sports Camp (HHHSC), sun exposure is unavoidable. It is the policy of HHHSC that staff will take reasonable measures to protect program participants and themselves against harm from the sun.

Purpose

To assist in providing a sun-safe environment for HHHSC program participants and staff.

Procedures for Residential and Day Campers, and HHHSC Staff

HHHSC will provide parents and guardians with information along with registration materials regarding sun-safety and exposure, as well as the items needed to comply (sun screen, suitable clothing, etc.). This is in hopes that parents will adhere to the policy and prepare their child as necessary. Included with the registration materials will be recommendations that sun screen be applied prior to drop off (both day and residential campers), and that a sunscreen suitable for the camper is packed in their bags. Due to a high number of varying skin sensitivities and allergies, HHHSC will not provide campers with sunscreen.

HHHSC staff will encourage other staff and campers to wear sunglasses and a hat at all times while outside. In instances where wearing a t-shirt would impede staff from performing duties, such as swim instruction, other methods of protection from the sun will be employed. Cabin Leaders will supervise and remind campers to apply sunscreen and wear appropriate clothing every morning, and throughout the day to ensure reapplication is occurring. If a staff is to assist in application of sunscreen, it will be done in a public, open area, with two or more staff members present. HHHSC staff will also ensure there is adequate shade available and notify a supervisor if they notice a child is showing signs of adverse effects of sun exposure, and will contact the parents when appropriate.

Parents will be provided with a form acknowledging awareness of the sun-safety policy, with an additional option of a release form to request assistance from HHHSC staff to assist with application (or re-application) of sunscreen. HHHSC staff will be provided with a list of those campers who have requested assistance with sunscreen application.

Parents will be contacted by phone if a camper refuses to follow sun safety procedures.

THINGS YOU SHOULD BRING WITH YOU IN YOUR BACKPACK or DUFFEL BAG

Note: Please no hard suitcases for storage purposes

- 🏆 Sleeping Bag or your own bedding: comforter or blanket & sheets
- 🏆 Pillow and Pillow Case
- 🏆 Personal Toiletry Kit including: toothpaste/brush, soap, shampoo, hand towel, face cloth, hairbrush, feminine hygiene products
- 🏆 Sunscreen SPF 30 or higher (waterproof recommended) HHH does not and cannot provide sunscreen. Every camper must bring their own.
- 🏆 Bug repellent with DEET – concentration no greater than 10% for youth and 30% for adults
- 🏆 Prescription medication (forms filled out and given to Directors of Haliburton Hockey Haven Sports Camp)
- 🏆 Two towels (one for beach and one for shower)
- 🏆 Swimwear (appropriate for water sports & active camp activities)
- 🏆 Socks (include a warm pair, for example: wool)
- 🏆 Underwear!
- 🏆 2 Pair of pants (light and loose)
- 🏆 4 Pair of shorts
- 🏆 2 Pair of footwear (one pair of running shoes or hiking boots for active wear and one pair of sandals or water shoes)
- 🏆 5 T-shirts (includes both short and long sleeve or light sweater)
- 🏆 Warm sweaters (hoodies) or sweatshirts – fleece is ideal
- 🏆 Rain wear (rain jacket and pants preferred)
- 🏆 Hat (bucket, baseball etc.) Bug hat – if you have one
- 🏆 Personal items: cards, instruments, books, writing paper, camera and film (waterproof / disposable), flashlight (check batteries)

- 🏆 Please do **NOT** bring any food or snack products to camp. HHH is a NUT CONTROLLED FACILITY. Any food brought to camp will be confiscated and disposed of in a proper manner.
- 🏆 HHH has a **STRICT NO CELL PHONE/DEVICE/ELECTRONICS** policy (including laptops, tablets, other computers, electronic games etc). These items are not permitted so that Campers can experience camp the way we believe it should be experienced – if Campers are found with or using them, they will be required to be checked with Camp staff for the duration of their stay.
- 🏆 HHH is not responsible for any lost or stolen items – Please leave all valuables, electronic devices, keepsakes and Jewelry at home
